# Managing Your First Thanksgiving After a Divorce:

## The Ins and Outs of Surviving The Big Holiday

**T**he holidays can be the best time of the year for many families. They can be a time for togetherness and memories- where cell phones are put away and old times are shared across generations. The stresses of the year are forgotten if only for a short period of time. All in all, Thanksgiving and Christmas may be among the only days all year that you are able to see multiple members of your family all on the same day, in the same place.

On the other hand, if you have recently been through a divorce, Thanksgiving can be among the more stressful and unenjoyable times of the year. It is possible that you do not get to be with your child during the holiday depending on the terms of your Final Decree of Divorce. Also, because this is the first Thanksgiving without your spouse, your family will likely not look the same. Combine these factors with financial difficulties as well as the questioning that newly divorced parties often face and you may feel like it would be best if Thanksgiving were to pass you by altogether.

It does not have to be this way if you have gone through a divorce. I am not prepared to say that a divorce is going to always be a positive thing for you, your family and most importantly your child. However, I will say that you and your family can prepare for the events of Thanksgiving. If this is your first Turkey Day as a divorced parent, you should think ahead about how to not only get through your first solo Thanksgiving, but how to make sure it is a memorable one for your child- in a positive way.

While we understand that your family may have a specific dynamic that sets you apart from most families, we believe the majority of what you read today will be applicable to you. As long as you approach the holiday with a flexible attitude and some patience, we believe that you can parent your child and create memories in the upcoming holiday.

- What's that, you say? You don't feel too grateful?

After all- you've just been through a difficult divorce that cost you your spouse, time with your child and money from your pocketbook. If anyone has an excuse to feel ungrateful it should be you, right?

Wrong. Each of us has things in our life that we can be grateful for. Simply being alive and being able to stand on our feet each morning with the possibilities that life offers is reason enough to be grateful. Being able to spend the day with your child is another reason to be grateful. I can almost promise you that you have friends in your life who have supported you during your divorce. Ditto for family. If you can take solace in these things and show gratitude on this day that behavior can influence your child to do the same thing.

While not everything in your life is going perfectly at this moment, there will not be a time that you will be able to say that everything is going perfectly, either. Life is about peaks and valleys. Nobody would argue that you may be going through one of the "valley" points in your life, but perk up- if for no other reason than you

have an opportunity to present a teachable lesson to your child in the form of how to show gratitude.

Keep things the same- as much as you can.

- Everything in your life (and I mean everything) may be different this Thanksgiving compared to last. You may not be hosting this year's meal like you did last year. Your spouse is no longer at home with you and your child. Family members may have had to act as witnesses in a messy divorce trial or at the very least have had to "pick sides" in the case. The relationship that you have with your child may be changing as well, which has led you to feel uncomfortable and uncertain of how to approach this day.

My advice would be to take whatever traditions your family normally practices and to do your best to recreate those this Thanksgiving. Try to keep a routine as similar to the one that your child previously enjoyed- even if it means putting forth a little bit more effort than you would normally show. Again- your child is the person you are doing this for, not you.

Your child wants to be reassured that their family is going to be OK, that both their parents still love them and that there are some aspects of their topsy-turvy life that will not be altered due to the divorce. The holidays are such a special time for kids that you have a very strong opportunity to create that sense of normalcy right here, right now.

I understand that you likely do not feel your best as the year grows shorter and our days are full of time with family and recollections and memories about your former life.

- It's enough to make you feel even worse for what you have been through, and to feel pessimistic about the future that appears uncertain.

While you attempt to sort through all of the

feelings that you are going through, do not forget that your child is feeling all sorts of new emotions at this time as well. Rather than dismissing those feelings as unimportant or something to suppress, it is better to acknowledge those emotions and feelings in order to show your child how to healthily and effectively manage them.


Part of acknowledging their feelings is to not pave over them with "parent speak" that intended to make you feel less guilty about what you and your ex-spouse have gone through. Telling your child that you understand that they are feeling bad is a good first step. Ignoring the

issue or trying to show your child that things aren't as bad as they may seem may make you feel good but probably won't have that effect on your child.

Your child wants to feel like you are hearing them. The only way to communicate this to your child is to engage with him or her directly and make certain that he or she realizes that you understand how they feel and will do whatever you can to

make this a great holiday.

Work with your ex-spouse on making sure the holidays are a success.

- Communicate with your ex-spouse about how your child is doing to see if there is an opportunity here to problem solve with him or her. If you are a parent of a small child that is going to spend Thanksgiving with your ex-spouse, be sure to pack all clothes, toys and other items that will make the holiday a good one for your child. Do not use Thanksgiving as an opportunity to score points against your ex-spouse. Encourage your child to have a good time and make sure your child knows that you support him or her.

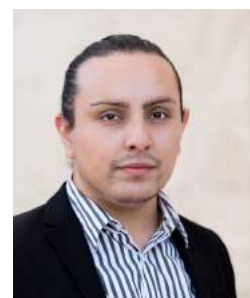

# Hidden Consequences of a Class C Conviction in Texas

In a previous article, *Texas Crimes Punishment*, I discussed the different ranges of punishment a person charged with a crime in Texas may face. Today, we will delve deeper into that topic, focusing specifically on Class C Misdemeanors, including the hidden consequences of the charge and how to make sure it stays off your record.

## ***The right to carry a firearm:***

Your right to carry a firearm can be revoked for 5 years based on several different crimes, including a certain class C misdemeanor known as “disorderly conduct”. Disorderly conduct can fall in any of the following categories, including when a person,

- (1) uses abusive, indecent, profane, or vulgar language in a public place, and the language by its very utterance tend to incite an immediate breach of the peace;
- (2) makes an offensive gesture or display in a public place, and the gesture or display tends to incite an immediate breach of the peace;
- (3) creates, by chemical means, a noxious and unreasonable odor in a public place;
- (4) abuses or threatens a person in a public place in an obviously offensive manner;
- (5) makes unreasonable noise in a public place other than a sport shooting range, or in or near a private residence that he has no right to occupy;
- (6) fights with another in a public place;
- (7) discharges a firearm in a public place other than a public road or a sport shooting range;

- (8) displays a firearm or other deadly weapon in a public place in a manner calculated to alarm;
- (9) discharges a firearm on or across a public road;
- (10) exposes his anus or genitals in a public place and is reckless about whether another may be present who will be offended or alarmed by his act; or
- (11) for a lewd or unlawful purpose:
  - (A) enters on the property of another and looks into a dwelling on the property through any window or other opening in the dwelling;
  - (B) while on the premises of a hotel or comparable establishment, looks into a guest room not the person's own through a window or other opening in the room; or



(C) while on the premises of a public place, looks into an area such as a restroom or shower stall or changing or dressing room that is designed to provide privacy to a person using the area.

## ***The right to receive federal financial aid and/or enter college:***

Certain Class C misdemeanors, such as possession of drug paraphernalia, disorderly conduct, or public fighting, can potentially be used against you to prevent you from receiving financial aid or getting into a college.

## ***How to keep a Class C misdemeanor off your record:***

Most of the time, if a defendant cannot obtain an outright dismissal of the charge, deferred adjudication is offered for a Class C misdemeanor. Deferred adjudication is a term of usually 180 days for a Class C misdemeanor (usually longer for class A and B). If you are not charged with new citations or crimes, your case will be dismissed at the end of the 180 days. Unlike Class A or Class B deferred adjudication cases, you will be able to expunge your case at the end of the deferred term of a cClass C misdemeanor. After successful completion of a deferred term of a Class A or B misdemeanor, you may only be able to seal the case, but not expunge it. ## ***What if I just pay the fine, can I get it off my record?***

If you pay the fine for a Class C misdemeanor, it means you are accepting a guilty plea and receiving a conviction. A conviction on your record cannot be sealed nor expunged.

## ***Point System:***

Prior to September 2019, your driver's license could have been taken away as an indirect result of Class C misdemeanors and/or traffic violations, based on the Texas Points Systems. This system would penalize an individual by assessing surcharges based on the number of points tallied by an individual. The good news is that this is no longer the case and driving privileges cannot be taken away from a Texas resident solely based on unpaid surcharges.

# *Selling Your Home in a Divorce:*

## Tips to Stay Calm and Move On

**D**ivorcing couples often have to make a host of difficult decisions before they can move on with their lives and face a new emotional and financial reality.

At the top of the priority list is thinking about the kids, followed by figuring out what to do with the home, according to Debbie Miali, a top real estate agent in The Woodlands, TX, specializing in working with divorcing couples to sell their homes.

In Miali's experience, usually one or both spouses wants to keep the home — desirability isn't the issue.

However, most of the time it's fairly simple to remove someone's name from the title of a home, it is a bit more complex to get someone off the mortgage. If both spouses originally qualified for the mortgage, it's possible that neither would qualify on their own, especially in more expensive markets.

This experience then leads many divorcing couples into what may be their only option: to put their home on the market and sell it.

Talk about stressful! According to Holmes and Rahe Stress Scale, a tool mental health professionals use to categorize taxing life events, divorce is the second-most stressful life event, and moving is among the top 30. Together? Well, that's going to be a lot to handle at once.

As Miali explains, above all, you don't want to let the stress of the divorce impact the marketability of your home.

Here are some great top tips to sell your home in a divorce quickly, successfully, and without creating any more strain during an already-trying time in your life:

### **Don't Move Out Too Soon When Selling Your Home in a Divorce**

Oftentimes, Miali says, most divorcing couples

want to move out of the home they're selling and move on, but that can be a mistake. It is greatly suggested for at least one party to stay in the home.

The problem with both spouses leaving the home is that they will usually take their stuff with them, leaving behind an empty house that is less attractive to buyers. A home always shows better with furniture in it so the buyers can visualize how their own furniture would fit.

It is possible that you could stage the home, a strategy that 39% of seller's agents say can greatly decrease your time on market, according to research from the National Association of Realtors. But staging a home can be quite expensive, says Miali, whose clients have often spent thousands on staging their empty homes. If it is possible, keep some nice furniture, fixtures and accessories in the home, that will bring down your expenses immediately.

Another benefit of having at least one person living in the home until it sells is keeping your monthly housing expenses in check—it is very difficult to have three housing payments every month between divorcing couples.

Miali recommends couples to wait until their closing is guaranteed at the closing table before both moving out of the home. After all, getting divorced isn't cheap: the average mediated divorce costs couples \$5,000, and the average contested divorce is more like \$15,000–\$30,000.

Save where you can!

### **Find an Agent With Experience in Divorce To Help Sell Your Home**

Like with any home sale, your first step will be to find an agent to help you sell your home. It is well worth it to find an agent who specializes in working with separating couples, a situation that presents some unique challenges.

Your real estate agent has the ability to double as a mediator, according to Miali.

"It seems as though most people going through a divorce require more hand-holding," she says. "Unfortunately, couples are coming to the closing table with mistrust, fear, and anger."

Find an agent that you both can trust and feel comfortable with, so that as the process goes on, neither of you feel that the agent is on the other person's "side."



Even in the best-case scenario, hopefully where the divorce is completely amicable, it is in the best interest of both of you to have an agent that understands the particular communication challenges of this situation.

Miali gives an example: Normally, an agent can tell one partner there's a planned open house on Saturday from 1–3 and

expect them to communicate that to the rest of the family. In a divorce, agents have to realize that couples are not communicating reliably.

"In a divorce situation, generally every single communication needs to be communicated to both parties, she says. "Every text message, every email, every phone call, every voicemail, you have to make sure those communications are corresponded correctly so one spouse doesn't feel like they're in the dark."

One spouse feeling alienated from the process, or having the sense that conversations are happening behind their back, can make the entire





sale a more strenuous experience, creating unnecessary drama and hurt feelings.

"You want to hire an agent who is really going to be your advocate, who will go above and beyond and outside of your traditional scope because you're dealing with a lot of emotions and stress," says Miali.

### Make Sure You Agree On Price and Scheduling Before You List Your Home in A Divorce

Another great reason to go with an experienced agent in divorce is that he or she will urge you to agree on key details before the home is listed, so that you don't hit a bump in the road mid-sale.

Before you list your home, decide:

- What is the lowest offer you're willing to accept?
- Who will remain in the home, and who will leave?
- How you pay for any staging costs or repairs?
- What services like cleaning, minor repairs, and painting will you be willing to hire out?
- How involved in the day-to-day marketing of the home does each person want to be?
- Will the spouse who has moved out be OK with not knowing about every single

viewing appointment, or is it important that both be in the loop for every detail?

- What are each spouse's specific responsibilities in terms of the home sale?
- What real estate agent will you use, and do you both agree on their fee?
- What is your pricing strategy?
- How much notice does each spouse need for a closing date?
- If you are in a state that uses real estate lawyers, do you agree on the attorney for the sale?
- What times are off-limits for appointments, and will the spouse living in the house be expected to accommodate last-minute showing requests?

# Talk Like a Lawyer



## Spousal Maintenance-

*Under the Texas Family Code the Court can order spousal maintenance if parties have been married for at least 10 years and one or more of the following circumstances is present: (1) the requesting spouse lacks sufficient property or income to meet his or her minimum reasonable needs, (2) there has been domestic violence in the marriage within the two years of filing for divorce or while the divorce is pending, (3) or a party is unable to meet his or her minimum reasonable needs due to a disability of the party or that of a disabled child.*

## Parenting Apps -

*Online applications which help to facilitate communication between divorced or separated parents. The apps allow the parties to communicate with each other, share calendars, notify the other party of events, and share expenses. The court is able to access the history between the parties and consider evidence obtained from the app to make decisions regarding orders for the children.*

## Ad Litem –

*an attorney appointed by the court to provide legal services to a person unable to represent themselves in court such as a party that has not been served and cannot be found, a child, or an incapacitated person.*

## Bill of Review –

*a bill of review is used to request a new trial in case that a court has previously closed after making a final decision on the matter. A Bill of Review may be filed up to four years after the order was signed by the judge in the underlying case.*

## Motion for Continuance –

*this is a request to the court to reschedule a hearing, typically a trial date, to a later date. This is typically needed when parties require more time to work on a case. For example, an attorney may request a continuance if the parties have not attended mediation or completed discovery.*
