#### SEPARATE PROPERTY VS. COMMUNITY PROPERTY

There are three types of marital property - separate property of the wife, community property, and separate property of the husband. All marital assets can be characterized as one of these types, or a combination of them. In Texas, the court will presume that all property the spouses own iscommunity property. It is up to the spouse claiming property as his or her separate property to overcome the presumption by proving very clearly to the court the separate property character. The benefit of an asset being characterized as your separate property is that the judge cannot award it to your spouse.

Characterizing all of your marital property as either separate property or community property is vital to fairly dividing your assets during a divorce. Consulting an experienced and knowledgeable attorney is the only way to ensure your assets are properly characterized before they are divided or confirmed by the court as separate property.

#### **BUSINESS VALUATION**

If you own a closely-held business or have family business interests, a primary concern in the divorce process will be valuing the business and determining its marital property character. We work closely with our high net worth clients, in conjunction with valuation and financial experts, to obtain a clear picture of the nature of your business interests and their current value. After your business interests have been appraised and a settlement agreement or final divorce decree is drafted dividing the property, it will be important that the actual division of the business is handled with expertise.

This documentation must be included in the mediated settlement agreement, final divorce decree, and in the internal resolutions, minutes, ownership certificates, shares, and relevant agreements of the business entity. If not properly documented, the division of the business will not be completed and conflict between ex-spouses or with the other persons involved in the business is likely to occur in the future. #### **BUSINESS INTEREST**

If the business interest is community property, the lawyer must consult with experts in other fields to value it.

After the business is valued by an expert or a value is agreed upon by the parties to the divorce, the attorney will advise the client of his or her legal rights and develop a strategy to facilitate an agreed division or, if necessary, present the case in the most favorable light to the court.

#### **BUSINESS ASSETS**

#### MARITAL PROPERTY DISPUTES

Before property can be divided, you must know whether it is separate or community property, and you must know its current value. Distinguishing the type of marital property (i.e., community or separate) is called characterization. Determining the current value of the assets is also called valuation. When disputes arise in a divorce case, it's important to have an experienced attorney on your side to help you sort through all the details.

#### **CHARACTERIZATION OF PROPERTY**

Determining whether property is considered separate property or community property is contingent on various factors such as whether it was attained before or during the course of the marriage. Other factors are much more complex such as when an asset (e.g., a 401(k) or pension plan) has a mixed character.

#### **VALUATION OF PROPERTY**

Stock in publicly traded companies and checking and savings accounts can be easily valued. Other assets such as stock options, retirement plans, pension plans, business interests, and professional practices have value that is not easily determined. Many times, valuation of more complex assets requires a team of experts working together, including your attorney, accountant, certified appraisers, and other professionals.
